3 Final Report

3.1 ADDITIONAL FOR FINAL REPORT: General summary of the project implementation

Lonjsko Polje Nature Park Public Institution signed a contract with HDZPP and EuroNatur as a part of the project team in the beginning of 2014. Responsibility was to implement the proposed activities which are mainly focused on the establishment of the SavaParks network, guiding principles on the nature conservation, river restoration and sustainable development, monitoring of indicator species, pilot project restoration and presentation and promotion of the SavaParks network.

Since then, 20 institutions for management of the protected areas along the Sava River from four Sava River countries - Slovenia, Croatia, Bosnia and Hezegovina and Serbia formed a strong network with a common goal in the preservation of floodplain and riverine ecosystem and biodiversity.

LPNPPI has actively participated in all phases in forming network, organization of the kick-off meeting in Krapje and other meetings in Zagreb and Una NP as well as the preparation of the SavaParks documents – SavaParks Memorandum, Declaration on the SavaParks Netowrk and Guiding Principles (all minutes from the meetings and press conference have been sent according to contracted timeframe).

In 2015, during the meeting in Novi Sad the network members agreed to develop a follow up SavaParks project by preparing the proposal planned to be applicate on the Call of the Danube Transnational Programme. Deadline for the upcoming activities were included in the Novi Sad minutes:

- 1) By 15th June 2015 send to all project partners:
 - Project proposal with detailed description of WPs
 - form for evaluation of the proposed project activities
 - form for basic information on each project partner
- 2) By 30th July 2015 project partners should send their decision on the participation in the call for DTP

On the LPNPPI internal meeting on 15/06/2015 it was decided that Goran Gugić assumes the implementation of the activities related to the ongoing SavaParks project and application for the future SavaParks project for the Danube Transnational Programme Call. In August 2015 Goran Gugić left his job in Institution. In that time and because a lot of other urgent nature park activities and ongoing national projects that should be finished by the end of 2015 it was not possible to appoint other employee to work on the future Savaparks project application. It was stated that it is never problem to implement the contracted activities as a project core team. It is a problem to take over a lead role and to find a working time and employee who will work on the follow up project application of the Savaparks Network. Therefore, it was decided to withdraw from the project core team and participate in the Savaparks network as a partner and member organization only.
